### **Professional Biography**

Dr. Wendy E. Coughlin is a seasoned clinical and forensic mental health professional with over four decades of experience in psychotherapy, substance use evaluation, family court consultation, and high-conflict family systems work. She is licensed in Florida (LMHC, MH 1919), certified as a Master Addiction Counselor (MCAP / MCAC), a Florida Supreme Court-certified Family Mediator, Qualified Parenting Coordinator (6th, 12th, and 13th Circuits), and a Certified Guardian ad Litem.

Her clinical work spans individual, couples, adolescent, and family therapy with deep expertise in substance use disorders, trauma, dissociative phenomena, complex adjustment issues, and co-parenting conflict. She regularly performs court-ordered mental health and substance abuse evaluations, often requested by attorneys and judges, and is qualified to provide DUI evaluations and forensic second opinions. Her evaluation reports synthesize collateral data, testing, interviews, observations, and document review, and typically include diagnostic impressions plus actionable treatment or parenting recommendations.

In family law contexts, Dr. Coughlin offers consultation, parenting plan design, mediation, and expert testimony. She is well known for intervening in parent/child contact disputes, reunification, parental alienation dynamics, and high-conflict custody cases. Her approach is interactive and solution-driven: she engages with families directly, coordinates with other professionals, and aims to bring clarity to court actors through rigorous, objective reporting. Her guiding belief is that sincere willingness to change can lead to life improvement, and she brings optimism, adaptability, and depth of clinical tools to each case.
